

## MEMORANDUM OF UNDERSTANDING

### BETWEEN

1) Dr. M. B. Mehta, Director, Institute of Management Studies, Career Development and Research (IMSCDR), Ahmednagar 414 001 through its hereafter known as IMS, Ahmednagar

And

1) Hon. Shri Siddharam Salimath , IAS, District Collector and District Magistrate, Ahmednagar 414001 Government of India

And

2) Shri Nishant Suryawanshi, Assistant Commissioner, District Skill Development, Employment and Entrepreneurship Guidance Center, Ahmednagar

WHEREAS, IMS Ahmednagar has received 'AICTE ' New Delhi and S.P. Pune University, under the courses

- Master of Business Administration (Marketing, Finance & HR)

WHEREAS, practical training / Internship is part of the syllabus for completion of the degree.

AND WHEREAS, the Internship Service Provider is in professional business related to the above courses

Both the parties have mutually decided to have a Memorandum of Understanding as under:-

#### 1) Terms :

- This MoU shall become effective as of the date of its execution and shall continue in the effect of its period for 60 days from the date of execution.
- IMS, Ahmednagar will provide a list of interested students with all the required details to the internship service provider.
- The Internship service provider may conduct a interview or otherwise and select the students for the internship at their business location.
- The internship service provider will not be obliged or required to select any students unless the internship service provider is satisfied with the students ability to complete the internship.
- The internship service provider will be required to pay remuneration/ stipend of ₹ 5000/student/month.(including transportation/ other allowances)
- The internship service provider will ensure that the students selected complete their internship with regular attendance. The internship service provider will be required to give a certificate of completion of internship to the students who complete the internship training.

- It is clearly understood that the internship service provider is not obliged to employ any student.
- IMS, Ahmednagar will ensure that the students selected for internship regularly and punctually carry out the internship at the business location of the internship service provider.
- The MoU may be modified on mutual terms by both the parties.



- Collection of information for preparation of District Export Plan




