Development Strategy for Ahmednagar District

There are many aspects of development of a district. This includes infrastructure development, industrial growth, agriculture focus, roads, water and provision of essential services.

The plans can be made for short term, medium term and long term.

The important aspect of any planning is the timely and efficient implementation of the plans. For any plan to succeed, the Government and political leadership is important and necessary.

It has been a very thoughtful initiative of the district administration under the able leadership of District Collector to involve various stakeholders in the preparation of the development strategy for Ahmednagar district.

IMS Ahmednagar is one of the leading management institutes in Ahmednagar. Some of the ideas for development strategy for Ahmednagar District discussed by the staff and which could be considered are as under:-

- PREPARATION OF THE PERSPECTIVE PLAN for 10-15 years. Within this plan, short term plans for 1year / 3 years/ 5 years etc. can be incorporated.
- 2) As per available data, Ahmednagar District is one of the top performers in the Primary Sectors contribution to GDP. Hence there is substantial scope for setting us 'AGRO BASED INDUSTRIES PARK at different taluka places so as to process the agriculture produce, including milk processing and milk products.
- 3) AT LEAST 2-3 MEDICAL COLLEGES CAN BE STARTED in the district in the private sector / public sector partnership mode. One such hospital can be started by the Ahmednagar Municipal Corporation at CIVIL hospital jointly with private sector. This will help to promote the health sector and at the same time could generate substantial revenue in the long term.
- 4) WASTE DISPOSAL PLANT can be started at various urban locations. This will help in waste management and could possible help to generate electricity as an output. For this CORPORATE SOCIAL RESPONSIBILITY CSR funds can be used. The Corporates running successfully in Ahmednagar at various MIDCs can be tapped.



- Ahmednagar is a known HISTORICAL PLACE. The various historical sites can be commercially properly developed and included in the tourism circuit.
- 6) NEW IT PARK. The existing I.T. park is fully saturated. There is an urgent need and potential for starting new I.T. parks in the district. This will help to improve the performance of Ahmednagar District in the TERTIARY Sector.
- There is ample scope for promoting RELIGIOUS AND RURAL TOURISM in Ahmednagar district.
- 8) AHMEDNAGAR DISTRICT as a BRAND has to be created, developed and made aware on a national / international level. This will definitely help in the growth and development of the district
- 9) MAINTENANCE and CLEANLINESS of road side places open spaces etc. Sponsorship can be invited from reputed persons, firms and corporates for such maintenance. This will help to make Ahmednagar more Green and clean.
- 10) ARTIFICIAL INTELLIGENCE AND ROBOTICS is the future. Robotic labs can be set up in various taluka places to promote awareness and expertize in these new upcoming areas.
- 11) LONG TERM PLAN FOR WATER SUPPLY for residential, agriculture and industrial purposes should be prepared based on potential population growth, growth of industrial parks and agriculture coverage. It should be kept in the mind that there is water for everyone's need but not enough for everyone's greed.
- 12) EDUCATION at the school level needs to be improved specially in Government schools. A proper survey can be taken to study the quality of education provided in such Government schools and accordingly changes can be made so that quality school education is made available to the needy and poor sections of the society in these Government schools.
- 13) SIMILAR SURVEY OF PRIMARY HEALTH CENTERS can be carried out so that the quality of health services provided can be improved at all Government primary Health Centers and Civil hospitals. The needy can be made aware of the different state and Central Government Schemes available for medical treatment.
- 14) SKILL DEVELOPMENT CENTRES can be started at various talukas to promote various skills and provide employment.



These are some important suggestions which can be incorporated in the Development strategy for Ahmednagar District.






