

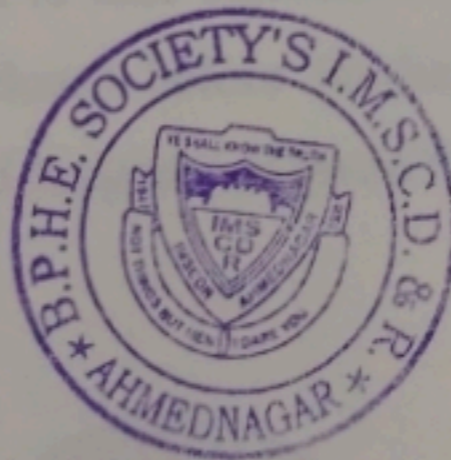

The meeting of the Board of Control of IMSCDR was held on 28th November 2020 at 11.00 a.m. on virtual mode.

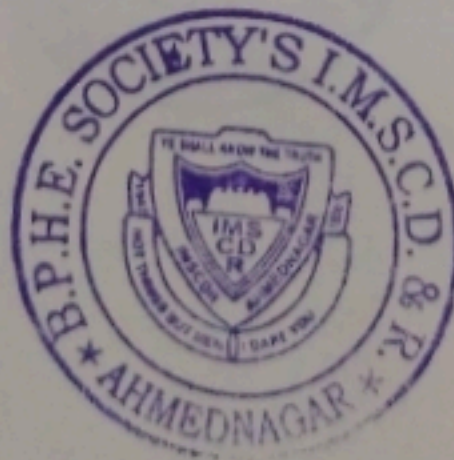
Agenda point no. 4 : NAAC – Discuss on action on Academic Calendar/plan and action on Feedback of students, teachers & other state holders.



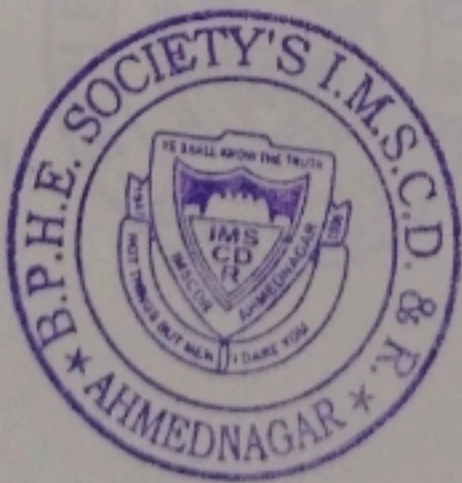


